- The Renewal Fee is \$200 for Associate (see notice below) and 20 CEU hours are required (consisting of 5 hours in clinical MFT; 3 hours in diagnosis and treatment; and 3 hours in professional ethics).
- The Renewal Fee is \$300 for LMFT (see notice below) and 40 CEU hours are required (consisting of 10 hours in clinical MFT; 6 hours in diagnosis and treatment; 6 hours in professional ethics; and 5 hours in supervision for LMFT Supervisors).
- The Renewal Fee is \$100 for LMFT Approved Supervisor (5 supervision CEU hours required).
- The Renewal Fee is \$25 for Intern and 10 CEU hours are required (consisting of 3 hours in clinical MFT; 3 hours in diagnosis and treatment; and 3 hours in professional ethics).
