Board Meeting Minutes

September 19, 2014

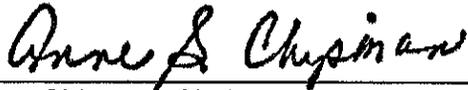

Anne Chipman approved a committee of Bobby Malone, Jeremy Blair, and Linda Enders to review and approve applicant files.

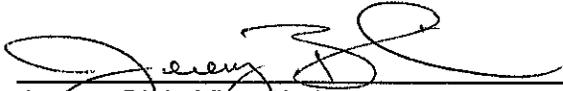

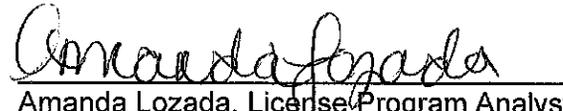
